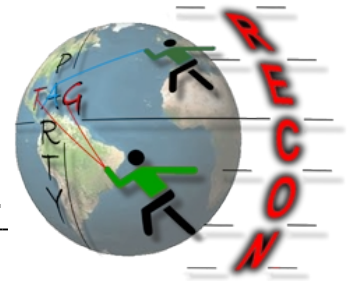


THIS IS A RELEASE OF LIABILITY

**THIS PERMISSION FORM MUST BE READ AND SIGNED
BEFORE THE PARTICIPANT IS ALLOWED TO TAKE PART
IN A TAGPARTY RECON ACTIVITY**



IN CONSIDERATION of being permitted to participate in any way in the activities of TagParty RECON activity, under the auspices of TagParty, the named participant (the "Participant"), and the Participant's parent or guardian, if the Participant is under the age of 18 years, acknowledge, appreciate, and agree that:

1. The risk of injury from the activity and equipment of TagParty RECON activity is similar to other sports and outdoor activities undertaken in woodlands containing natural hazards (terrain, fauna & flora). While appropriate attire, personal discipline and awareness of the surrounding environment will minimize this risk, the risk of serious injury including the potential for permanent disability and death does exist; I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and assume full responsibility for my participation; and,
2. I understand that a TagParty RECON activity is physically and mentally intense. I understand the rules of play and will comply with all the rules and regulations . If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as practical; and,
3. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS FROM ANY CLAIM, ASSERTATION, SUIT ACTION OR OTHERWISE, EUDENE A. ROSSI, INDIVIDUALLY AND TRADING AS TAGPARTY, HER PRINCIPALS, EMPLOYEES, OFFICERS, OFFICIALS, AGENTS, CONTRACTS, VENDORS, THE PROPERTY OWNERS WHERE THE TAGPARTY RECON ACTIVITIES ARE HELD, PERSONAL REPRESENTATIVES, HEIRS AND OTHERS ("RELEASEES") WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss or damage to person or property, including attorney's fees and defense costs, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, except by injury proximately caused by gross negligence or criminal misconduct.
4. I understand and agree that this Release of Liability Agreement covers each and every TagParty RECON activity in which I participate hereafter. I also understand and agree that, any and all pictures and videos taken by TagParty can be used by said company to advertise and promote it's business.
5. All claims in connection with this TagParty RECON activity shall be referred to and finally determined by arbitration in Maryland, governed by Maryland law before a single arbitrator who is a member of the American Arbitration Association, from which arbitration shall be binding on all parties and there shall be no appeal.

I THE UNDERSIGNED HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
